### CWS Teams Provide Support to One Another

CWS teams provide support to one another. It's just what we do. Whether sharing information and knowledge, or providing hands-on assistance during emergency situations, our company ensures that our teams and our clients have the resources that they need to be successful.

One such example of this teamwork occurred in late December when Alabama experienced a significant weather event dumping inches of rain in a short period of time across the state. The continuous heavy rains prompted flash flood advisories in many places, but a Flood Emergency was issued in Choctaw County, AL where over 10 inches of rain fell in a 48 hour period. Roads were impassable and some were even washed out leaving people stranded in their homes.

CWS's client, the North Choctaw Water & Sewer Authority, was also hit hard as tremendous levels of water caused two 8" lines to wash out in creek crossings. The road situation made matters worse as the team had a hard time reaching the broken pipes. Project Manager Jerry Price and his crew jumped into action to locate the issues and make the repairs, but as the situation was too much, they needed help. Team members from nearby projects - Torrey Jones and Tommy Beach from South/West Dallas Water Authority, and Billy Davis and Jacob Thomas from Billingsley Water Authority - came to the rescue. After four long days and nights, the team was able to successfully repair the lines and return water service to the residents of Choctaw County.

According to the CWS Regional Manager Lawrence Hughes, "the team wasted no time getting out and about to assess the situation. Jerry and his crew did a great job making the repairs as quickly as they could. Torrey, Tommy, Billy, and Jacob stepped up to help to provide valuable assistance. It was a lot of work in miserable conditions. I greatly appreciate their willingness to help out."

The EMA is now assessing the damage to see if they can provide funding for the repairs.

# DAVIS NAMED PROJECT MANAGER IN GAUTIER, MS

Russell Davis, an experienced manager with ClearWater Solutions, was recently named the Project Manager for the CWS project in Gautier, Mississippi. Russell's past experience includes 11 years in the industry - serving as the Director of the Public Works Departments for the City of Moss Point, the City of Hattiesburg, and most recently the City of Greenville.



In Greenville, Russell managed the Public Works and Fleet Maintenance Departments. In Moss Point, he successfully resolved the 40+ year old drainage problem on Rose Drive (a \$1.5 million project) and helped to secure funding for a \$4.5 million sewer project. Russell also implemented the \$2 million automated garbage system, as well as the recycling program, for the City of Hattiesburg.

"Russell has been serving as Gautier's interim Project Manager since the death of the previous Project Manager, David Lewis. He is familiar with the City officials, as well as the needs of the community. In his new role, Russell will be responsible for the day-to-day operations of the CWS team. He will work closely with City officials to ensure our contractual obligations are met.

It turned out that it was on Opelika Water Utilities' 30" force main. The leak was a fault in the Air Release valve. Mack and the Superintendent from Opelika, William Thornton, worked together to shut off the malfunctioned air release valve. William contacted Regional Manager, Houston Black, to thank Mack for his efforts, especially on Christmas day. Dan Hilyer, the General Manager at Opelika, contacted Beulah's Water Board to share his appreciation. According to Houston, "Mack was given a gift card from William in appreciation for his help. William told me that the flow of the leak was like standing in a manhole with a fire hydrant turned on wide open. A few hours out of Mack's day went a long way and several people noticed his willingness to go above and beyond the call of duty. Mack is a great asset to our company. ### 3 New Projects to Begin the New Year

The new year started with some new projects in Alabama and South Carolina. The **Pendleton, South Carolina** project is a short-term, labor-only contract to provide a licensed Wastewater Operator at the town's wastewater treatment facility. The CWS Operator is working with the existing staff to coordinate activities, maintenance, etc. related to the facility including collecting and analyzing samples, calibrating meters and equipment, and monitoring tank and sludge levels.

The second project is in **Anderson County, South Carolina** where CWS is the Operator of Record at the Six & Twenty Creek Wastewater Treatment Plant. CWS provides the preparation, completion, and submission of all Discharge Monitoring Reports (DMRs) to DHEC, as well as coordination of activities and maintenance related to the facility, performing all monitoring, testing, and lab testing, and submitting the monthly reports to Anders County.


The most recent addition is the **Clay County, AL Water Authority** project which provides a Project Manager to operate, maintain, and manage the water treatment plant for a three-month period. **Joel Landers** has been named the Project Manager for this project. Joel is a certified Alabama Grade IV Water Operator who will oversee and manage the day-to-day operations of the treatment plant.

Wesley Bass has also been named an Area Manager for the Lowndes County Water Authority, SafetyNet, and Butler County Water Authority projects. Wesley has over 27 years of experience in the utilities industry where he has managed the construction of numerous wells, tanks, and water line projects. He was also instrumental in getting SCADA systems established for various water systems. Under his authority, the Butler County Water Authority completed a \$5.5 million project to add generators at all of the wells and one booster station. New transmission lines were installed which helped solve contact time problems with the wells, and all the meters were switched from manual read to radio read. He also managed the rebuilding of the Logan system which had approximately 23 miles of mains and 220 services. Wesley has extensive experience with budgeting and long-term planning, as well as obtaining funding through such programs as the USDA, HUD, State Revolving Fund, CDBG, REDLEG, and others. Wesley is a certified Grade 3 Water Operator in Alabama.

### **CWS LAUNCHES SERVICE AWARDS PROGRAM**

The CWS Leadership Team is excited to announce the launch of our Employee Service Awards program. We know that the success of our company is only because of the hard work and commitment of our team. We don't take for granted the fact that you could work anywhere, but you have chosen to work with CWS. With that in mind, we would like to offer a small token of our appreciation for your loyalty to our company.

#### **HOW DOES THIS WORK?**

Once you have reached your 1st, 3rd, 5th, 10th, or 15th year anniversary with CWS, you are eligible for a Service Award. Your anniversary date is determined by the years you have worked for ClearWater Solutions. Our HR Department has the list of start dates, so don't worry about submitting those. At the beginning of your anniversary month, you will be notified that you are eligible. The program starts this week; so, if you are celebrating in January or February, you'll receive your information soon.

#### WHEN IS YOUR ANNIVERSARY DATE?

Here are some examples of how to determine your anniversary date:

- 1. If you worked for the City of Moss Point for 15 years and then rolled over to CWS when we started work there in February 2016, then your CWS anniversary date is February 2016 and you will be celebrating your 3rd anniversary this year. You will be getting notification that you have reached this milestone.
- 2. If you worked with ABC Tire Company and then were hired by CWS to work in Moss Point in July 2017, then you will be celebrating your 2nd CWS anniversary in July of this year. You will not be eligible for a Service Award this year, but you will get one next year at your 3-year anniversary date.
- 3. If you worked for Artesian when they were acquired by CWS, then your Artesian start date is your anniversary date.

If you have already celebrated your 10- or 15-year CWS anniversary, don't worry...you didn't miss out on your award! You will be notified in the month of your anniversary (this year) that you are eligible to receive a gift. Only the 10- and 15-year recipients will be "grandfathered" in to the program.

#### **HOW WILL I RECEIVE MY GIFT?**

When you have reached the month of your anniversary date and you are celebrating one of the levels mentioned earlier, you will receive a gift package at work. It will contain some gifts and a letter explaining how to order your Service Award. The letter will provide a website address where you will enter your information (name, address, etc.) and then you can choose from nearly 50 gifts based on your milestone level. There are tools, jewelry,
